## Campbellsville-Taylor County Economic Development Authority Minutes of Board Meeting held November 20, 2020

Members present: Mark Johnson, Jane Wheatley, John Chowning, Angie Call, and David Chewning. Also, present was Ron McMahan, and Jon Hieneman.

Chairman Mark Johnson called the meeting to order and David Chewning opened the meeting with prayer. Ron McMahan recited that the media had been properly notified of the meeting. Media notification was sent to John Overby at the CKNJ, Marty Bagby at Q-104, and Larry Smith at the Big Dawg.

Minutes from the October 9th, monthly meeting were reviewed. Minutes were approved by unanimous vote following motion by John Chowning and seconded by Jane Wheatley.

The October 2020 financials were presented by Ron McMahan. Motion made by Jane Wheatley, seconded by John Chowning to approve the October financials, subject to audit adjustments on the retirement accrual amounts (no monetary impact on the financial reports), between Sharlow and Associates and Wise, Buckner and Sprowles, passed by unanimous vote.

The Fiscal Year 2019-20 Board Review was presented by Shirley Buckner with Wise, Buckner and Sprowles. A Board Review was conducted in lieu of an annual audit, required as per KY statute every third fiscal year. Buckner once again reported a good, clean review. Review was approved by unanimous vote following motion by David Chewning, seconded by Jane Wheatley.

Motion made by John Chowning, seconded by Angie Call to approve purchase of an iPad Air and iPad Magic Keyboard cover.

#### Executive Director Ron McMahan's report:

- The next board meeting is scheduled for Friday, December 11, 2020.
- Heartland Commerce and Technology Park Fence replacement permit has been approved by KY Transportation Cabinet. EDA/INFAC property line at the new Bypass is to be remarked. Researching options for WIFI cameras for the industrial park to record and deter non-essential vehicular traffic. Installation of signs stating this area is under video surveillance will be installed.

Discussion about locations for the new recycling center and possible future fire substations.

- Provided demographic information to an out of state rental housing prospect.
- Project Press Contact with the Cabinet for Economic Development's Japanese Representative confirms this new prospects project is still active, but on hold because of Covid-19.
- Ron McMahan graduated from the AEDL (Americal Economic Development Leadership Program) with a Economic Development Master Practitioner (EcDMP) credential. Five universities (University of Southhern Mississippi, Clemson, University of New Mexico, Texas Christian University and The University of Alabama) collaborated to form the two week executive education program for continuing professional development.
