Campbellsville-Taylor County Economic Development Authority Minutes of Board Meeting held April 9, 2021

Members present via Zoom call: Mark Johnson, Jane Wheatley, John Chowning, David Chewning, and Barry Blevins. Also, present was Ron McMahan and Faye Howell.

Secretary/Treasurer Jane Wheatley called the meeting to order, and John Chowning opened the meeting with prayer. Ron McMahan recited that the media had been properly notified of the meeting. Media notification was sent to John Overby at the CKNJ, Corey Houk at Q-104, and Larry Smith at the Big Dawg.

Minutes from the April 9th, monthly meeting were reviewed. Minutes were approved by unanimous vote following motion by John Chowning and seconded by Barry Blevins.

The April 2021 financials were presented by Ron McMahan. Motion made by David Chewning, seconded by John Chowning to approve the April financials, passed by unanimous vote.

The FY 2021-22 draft budget worksheet presented by Ron McMahan. Motion made by David Chewning, seconded by John Chowning to approve the FY 2021-22 budget.

Executive Director Ron McMahan's report:

- The next board meeting is scheduled for Friday, June 11, 2021.
- Heartland Parkway The construction bid was awarded, and work is to start on the Campbellsville to Lebanon section in June 2021.
- RAISE Grant Applications are due by 7/12/2021 for federal funding of regional transportation projects. Discussions are taking place for a regional collaboration between Washington, Marion and Taylor Counties like took place on the 2019 BUILD Grant. The project is an eight mile section of KY555 in Washington County.
- Stanley building A mid-June closing is expected by the new, local owners. The building will still be available for sale or lease.
- Taylor County's unemployment rate for March 2021 was 4%, one of the lowest in the state. KY's Labor Market Participation rate for March 2021 was 56.7, the 48th lowest in the US. The February 2020 LMP was 59.3%, the 44th lowest in the US.

- Senator McConnell Roundtable Meeting The Senator met with seven, local manufacturing and non-manufacturing service employers for a discussion on doing business in today's environment. The meeting was held at Manchester Tank.
- Amazon.com Ron McMahan had a routing existing business visit with Emerson Silva, Site Leader. There were no concerns or red flag issues brought up. Business is booming and they could us hundreds of additional employees.
- Motion to adjourn was made by John Chowning, seconded by David Chewning and approved by unanimous vote.
