## Campbellsville-Taylor County Economic Development Authority Minutes of Board Meeting held January 12, 2024

Members present: Mark Johnson, Barry Blevins, and Jane Wheatley. Members present by Zoom: Angie Call, David Chewning, and John Chowning. Also, present was Shirley Buckner, Ron McMahan and Isaac South with Taylor County Bank.

Chairman Mark Johnson called the meeting to order, and Jane Wheatley opened the meeting with prayer. Ron McMahan recited that the media had been properly notified of the meeting. Media notification was sent to the CKNJ, Q-104, WGRK, and 99.9 the Big Dawg.

Minutes from the December 8th monthly meeting were reviewed. Minutes were approved by unanimous vote following motion by John Chowning and seconded by Barry Blevins.

The December 2023 financials were presented by Ron McMahan. Motion made by John Chowning, seconded by Barry Blevins to approve the December financials, passed by unanimous vote.

#### Executive Director Ron McMahan's report:

- The next board meeting is scheduled for Tuesday, February 9, 2024.
- Taylor County's unemployment rate for 11/23 was 3.5% Kentucky was 3.9% and the US was 3.5%.
- HCTP Farm Lease Agreement and Mowing Services Agreement for the 2024-2025 calendar were Advertised for Bids in December. The farm lease high bid was \$11,600 from Phillips Green Acres. The mowing services low bid was \$74.95 per mowing from Double R Fence and Lawn.
- Project GCT The prospect is waiting to get official notification from their customer in mid to late January 2024 before moving forward with a location decision. A draft Purchase Agreement was sent to the prospect for their corporate and legal team's review. It is for purchasing a 27.5-acre lot in HCTP.
- Project T As KCED project manager, they delayed their decision timeline until after the first of the year. A second site visit was made on Monday, November 20th. The prospect is considering their site options in KY. No decision timeline is available.

- Project M A site visit by the prospect's corporate team was be made the week of December 18th. They have interest in the 58-acre site in HCTP. Additional site information was requested and sent.
- INFAC An existing business lunch meeting was held with the INFAC corporate team will be on December 19<sup>th</sup>. The expressed interest in the 27.5 acre site.
- Project D Tech A South Korean prospect interested in the 27.5-acre BUILD-Ready site was made on 1/5/2024. They are a plastic injection molding auto parts supplier/manufacturer proposing a 55,000-60,000 SF building.
- Shirley Buckner with Wise Buckner and Sprowles presented the annual FY2022-2023 EDA board review audit. She stated all looks good for another clean board review. Motion made by Jane Wheatley, seconded by David Chewning to accept the board review as presented.
- Motion Made by Barry Blevins, seconded by John Chowning to go into executive session to discuss Project CGT.
- Motion Made by Barry Blevins, seconded by Jane Wheatley to return to regular session, and motion approved by unanimous vote.
- No action was taken in executive session.
- Motion made to adjourn was made by Jane Wheatley, seconded by Barry Blevins, and approved by unanimous vote.
