## Campbellsville-Taylor County Economic Development Authority Minutes of Board Meeting held July 12, 2024

Members present: Mark Johnson and Barry Blevins. Members present by Zoom: John Chowning, David Chewning, Angie Call and Jane Wheatley. Also present was Ron McMahan.

Chairman Mark Johnson called the meeting to order, and Angie Call opened the meeting with prayer. Ron McMahan recited that the media had been properly notified of the meeting. Media notification was sent to the CKNJ, Q-104, WGRK, and 99.9 the Big Dawg.

Minutes from the June 14th monthly meeting were reviewed. Minutes were approved by unanimous vote following motion by John Chowning and seconded by Barry Blevins.

The June 2024 financials were presented by Ron McMahan. Financials were tabled pending year-end adjustments to deferred revenue.

#### Executive Director Ron McMahan's report:

- The next board meeting is scheduled for Friday, August 8, 2024.
- Taylor County's unemployment rate for 5/24 was 4.4%, Kentucky was 4.5% and the US was 3.7%.
- Q 2 2024 Activity Report has been sent.
- Kentucky PDI 2024 (Product Development Initiative) Still waiting for the official factsheet and application for be released by KCED.
- Project F A detailed RFI was completed and submitted on a large food service-related manufacturer. After submission and review, the consultant and company had additional questions on local utility capacities and to verify Taylor County's eligibility for the New Market Tax Credit program.
- Project B S RFI was submitted. After submission and review, the consultant requested additional information on utility capacities.
- A large existing manufacturing company has inquired about state incentives for a potential expansion project. A Teams meeting was held with the KY Cabinet for Economic Development Project Manager, the company and Ron McMahan to discuss the state programs.
